Cable cars, ropeways, and the dramatic mountain landscapes. Discover Kanazawa's celebrated, Kenrokuen Garden, Kanazawa Castle, and the traditional teahouse streets of Higashi Chaya. the UNESCO Heritage village of Shirakawa-go, with its unique thatched gassho-zukuri farmhouses. Walk through Kyoto, Arashiyama Bamboo Grove, lively Nishiki Market, Kinkaku-ji Temple (golden pavilion) the iconic red torii gates of Fushimi Inari Shrine

Hiroshima's Peace Memorial Park, Atomic Bomb Dome, and admire the floating torii gate at Itsukushima Shrine on Miyajima Island. The spiritual serenity of Nara's Todai-ji Temple and its Great Buddha, Deer at Nara Deer Park. Osaka with shopping in Shinsaibashi and Dotonbori, panoramic views from Umeda Sky building.

Tokyo Skytree (350m), enjoy panoramic city views from one of the world's tallest towers. Sumida River Cruise ,a scenic boat ride from Asakusa to Odaiba -a futuristic waterfront area with shopping, entertainment, and iconic Rainbow Bridge views. Shibuya Crossing -the world's busiest pedestrian crossing, and the famous Hachiko statue nearby.

DAY 3: Tokyo – Mt. Fuji – Hakone – Matsumoto

Proceed to Mt. Fuji, Lake Kawaguchiko Cruise & Mt. Fuji Panorama Ropeway – admire the majestic views of Japan's iconic peak, Oshino Hakkai, a traditional village with crystal-clear spring ponds fed by Mt. Fuji's snowmelt. Continue to Matsumoto.

DAY 04: Alpine Route Experience - Toyama

Proceed to Shirakawa-go after breakfast, Shirakawa-go Village – UNESCO World Heritage site famous for gassho-zukuri thatched farmhouses. After lunch to Kyoto. Fushimi Inari Taisha Shrine – walk through thousands of vermilion torii gates.

DAY 7: Kyoto – Osaka

Arashiyama Bamboo Grove – stroll through Kyoto’s enchanting bamboo forest. Kinkakuji (Golden Pavilion, Marvel at the temple covered in gold leaf, Todai-ji Temple (housing the Great Buddha) & Nara Deer Park with its friendly free-roaming deer and arrive to Osaka.

Travelers are requested to submit Xerox copy of passport along with page showing the entry and exit stamp of passport page.

Direct joining guest(s) must have to reach to airport before 3 Hrs. after arrival and before departure time so please book your ticket accordingly and same for arrival at designated airport area for complimentary group transfer to from hotel. If you arrived and /or departure early and/ or late no private transfer will provide you have to manage or pay your own private transfer or request at the time of booking and we will arrange with extra cost. There is no refund for INR 7Lakhs exemption threshold limit qualify remitter declaration should be submitted by the consumer of international Tour package to **Krishna Tours and Travels /partners /providers** If You Cancel Your Trip the amount of Any GST, TCS paid is non-refundable. as per section 206CCA of Income Tax Act 1961

In case you have not filed your Income Tax Returns for two preceding years and the aggregate TDS And TCS of each Tax Year Is INR 50,000 or more on validating The PAN If it is found that you have not filed your income tax returns for two preceding years and aggregate TCS and TCS exceeds INR 50,000 or more, an additional TCS @ 5/20% (As the case may be) will be recovered from you or booking will get cancelled and cancellation charges will apply.
